## PRESIDENT'S MESSAGE

Dear Neighbors,

The first few months as President of the Chapman Woods Association have been busy and fruitful. I have had the opportunity to meet with many of you during several community meetings and have appreciated your counsel on the issues facing our wonderful community. For those not able to participate in these meetings the following will summarize the current status of various issues.

- The board and numerous homeowners have worked with Sergeant Ramos of Animal Control to alleviate critical dog situations.
- Lynda Patton, Bill Johnston (Zoning Czar), Mark Miller and I have worked closely with representatives of our elected officials especially Suzanne Reed (Assemblyperson Carol Liu's Chief of Staff) to arrange for Rosemead Blvd. to be resurfaced in 2003-4. The resurfacing project had to be approved before we could begin to obtain funding for hardscape on the median. - Our LA County Sheriff's Department, Temple Station, hosted a Town Hall Meeting at Wilson Middle School on April 4<sup>th</sup>. They shared with the 25 or so Chapman Woods homeowners the result of the interviews with our community. The biggest issue is traffic! As a result of this meeting I agreed to assist in setting up several follow up meetings as noted following.
- I had the opportunity to facilitate a meeting between the community surrounding our schools and the principals of both Willard and Wilson on Monday, April 22<sup>nd</sup>. About 15 residents attended the meeting. Most of the problems will be resolved when construction is finished in the fall.
