PRESIDENT'S MESSAGE

Dear Neighbors,

I have several interesting new developments to report in our ongoing conversations with the Los Angeles County Department of Public Works:

- *Justin Schmitz has replaced Nadim Bakhos as our local traffic engineering contact; his number is 626-300-4743.*
- A traffic count will be done in late January to determine whether a stop sign is justified for San Pasqual at Lotus. It will take place either January 21/22 or 28/29. I have also requested a crosswalk, so if you are interested in either the stop sign and/or the crosswalk make sure you are counted.
- I again requested a speed calming measure (such as collapsible speed cushions) for Grayburn Rd. I have been told this study will also take place in January. You may remember that 500 cars per day are required with a certain percentage exceeding the speed limit to qualify for this measure; the last study yielded 235 cars with a small percentage speeding.
- The handrail replacement project for the San Pasqual Bridge will finally be advertised for bidders in January and should be completed in March.
- The flashing yellow beacon for the crosswalk at Del Mar and Halstead has been approved and will be installed in November 2003.
- I am meeting with Justin Schmitz on Tuesday, January 21st at 4:00 p.m. to show him the traffic situation in the Woods. I am planning to show him Rosemead, Madre etc. Part of my concern is the impact of the Gold Line on traffic through the Woods. If you have concerns let me know and I will share them with Justin.
