

ZONING & TRAFFIC-Pam Bolenbaugh

I just talked to Bob Masuda of Cal Trans this morning, he said the County is currently working on a new ordinance for Rosemead from the 210 to Temple City to prohibit all truck parking over 10,000 lbs. The recommendation will be made to the County Board of Supervisors in September (probably) and then will be reviewed by Cal Trans and if approved the signs will be posted. All this may be done by the end of the year (maybe). I called the main complaintent, Jack Reberry and left him the above information. Also I asked about the plan to pave Rosemead this summer; he said that it is currently scheduled to be go out to bid in January 2004 with plans for paving in the summer of 2004. This may change since Sacramento (state government) will probably run out of money and then all projects will slide. •

Dear Mr. kau

As you know, Rosemead Boulevard is a State Highway and Cal Trans is responsible for improving and maintaining it. The issue of the center median has been debated for several years by the community and Cal Trans.

Over the years, my office has met repeatedly with representatives from Cal Trans, as well as, your local State representatives to discuss ways to interest Cal Trans in improving the Rosemead Boulevard medians. Unfortunately, we have made little progress in those efforts. Cal Trans maintains that their internal policy is to not improve center medians.

I share the community's frustration with this issue and have asked the Los Angeles County Department of Public Works to begin the process of relinquishment of Rosemead Boulevard from the Foothill Freeway to the Temple City boundary from the State to the County. I am pleased to take this first step to improve the appearance of the area however, please be advised that the process can take up to two years to complete.

I would like to thank your association for their efforts to resolve this historical issue and look forward to working with the community to make their visions of an improved Rosemead Boulevard median a reality.
